Rebates, Loans and Incentives for Cutting Energy Waste at Home

Low-interest financing:

Loans are repayable over five years for amounts \$10,000 or less and seven years on amounts exceeding \$10,000. An interest rate of 4.99% and a loan processing fee applies to all conservation loans and a minimum monthly payment of \$25 is required. A household may be eligible for more than one loan, not to exceed \$30,000 in total. **Apply online at www.clarkpublicutilities.com.**

All electrically heated homes, including manufactured homes, are eligible for both weatherization and heat pump financing (*subject to credit approval and home equity review*). Loans for work on manufactured homes are limited to \$7,500. All Clark Public Utilities customers are eligible for solar energy financing. Financing is not available for new construction and loans are non-transferrable. If you sell your home, you must repay the balance of the loan at that time. Loans are billed monthly, separate from your regular utility billing.

Solar energy financing is available up to \$30,000. Two bids are required with application.

Program eligibility:

Funding is limited to Clark Public Utilities customers whose homes are electrically heated. Program requirements and rebate amounts are subject to change without notice and may be subject to limits. Energy savings and project costs will vary. Measures must be installed by a contractor participating in the Clark Public Utilities Contractor Network.

Program and product specific requirements include:

- Double Pane windows* must be a .30 U-Factor or less, and must be installed in a conditioned space. (*U-Factor is an efficiency measurement*)
- Triple Pane windows* must be a .22 U-Factor or less, and must be installed in a conditioned space.
- Pre-existing windows* must be (1) single pane with/without storms, any frame type (e.g., metal, wood), or (2) double pane, metal frame only.
- PTCS** stands for Performance Tested Comfort Systems. PTCS program specifications help ensure each system is installed and configured to achieve maximum efficiency and comfort levels.

Contractor Network

To be eligible for utility program rebates and incentives, work requiring professional installation (*excluding heat pump water heaters and smart thermostats*) must be completed by a contractor participating in the Clark Public Utilities Contractor Network. Clark Public Utilities does not endorse contractors, manufacturers or products and provides no express or implied warranties of products or installations. Inclusion in the network requires contractors to be licensed, bonded and insured, and to have completed any trainings and certifications related to each energy efficiency program. Low-income weatherization and ductless heat pump program



Clark Public Utilities and Clark County operate a joint low-income weatherization program to provide more efficient weatherization service to low-income families. Clark County Community Development administers the program, which provides free insulation, minor weatherization-related repairs, and in some cases ductless heat pumps to families who meet program guidelines.

Both owner-occupied and rental houses, including manufactured homes, are eligible for this weatherization service, regardless of heat source, if the occupants meet the program income guidelines. Health, safety and comfort issues are all addressed as part of each weatherization project.

Clark Public Utilities provides funding used to weatherize electrically heated homes of qualified low-income Clark County residents. The county receives additional weatherization funding from several federal and state agencies for homes with other types of heat sources. Local matching funds make it possible to fully address the needs of each eligible home.
